**Attic Breeze Credit Terms and Conditions**

The individual signing this engagement letter below, whether individually a party hereto or acting in a representative capacity on behalf of the Company (“Buyer”) hereby agrees to, guarantees, and acknowledges the following terms and conditions of its account with Attic Breeze, LLC or any of its subsidiaries (hereinafter referred to collectively as “Attic Breeze”):

Full payment of Net Accounts must be received by Attic Breeze within thirty (30) days of date set forth on the invoice, or as otherwise stated on the invoice. Net Accounts, or any portion thereof, that are past due are subject to a late fee penalty equal to five percent (5%) of the total invoice amount. Additionally, Attic Breeze will assess a monthly service charge of ten percent (10%) on the past due amount (or up to the maximum allowed by law) until the delinquent account is paid in full. Service charge fees will be prorated and invoiced on a weekly basis while the account is delinquent.

In the event that the Net Account is transferred to an agency or to an attorney for collection, Buyer agrees that Attic Breeze will be entitled to recover the reasonable costs of collection, to the extent permitted by law, including all of such attorneys' fees and court costs, plus any late fee penalties and service charges accrued at the time of such referral as specified above.

During the period in which Buyer is delinquent in its payments, Attic Breeze may, without waiving any other rights or remedies to which it may be entitled, suspend its obligations to Buyer under this agreement or any other agreement and/or decide not to accept additional purchase orders from Buyer.

All parties to this agreement agree and acknowledge that this agreement is ratified in and shall be governed, interpreted and construed in accordance with the substantive and procedural laws of the State of Texas. All parties to this agreement further agree and acknowledge that any action at law, suit in equity, or other judicial proceeding for the enforcement of any provisions of this agreement or for any dispute arising out of or related to this agreement or any business transaction of any nature by and between the Purchaser and Seller shall be instituted only in the courts of the State of Texas. The parties hereby agree that the courts of the State of Texas shall have in persona jurisdiction over the parties and that the venue of the action shall be appropriate in any county in the State of Texas, and each party hereby waives the right to change of venue. Buyer hereby acknowledges that its consent to choice of law, in persona jurisdiction and venue in the State of Texas is a material inducement to Attic Breeze extending credit to the Buyer and that Attic Breeze would not have extended credit to Buyer without such acknowledgment, and that Buyer acknowledges that it has been represented by an attorney, or has had an opportunity to consult with an attorney in connection with such consents and understands the legal effect of this paragraph. Nothing in these terms and conditions shall limit Attic Breeze’s right to bring a legal suit, action or proceedings against Buyer in another State Court or other forum of proper jurisdiction.

Attic Breeze reserves the right to unilaterally terminate this agreement at any time for any reason.

If any of the provisions contained in this agreement are held invalid, illegal or unenforceable in any respect, the validity, legality, and enforceability of the remaining provisions contained herein shall not in any way be affected or impaired thereby.
